



Room Reservation Process

1. Visit the website: <https://nospr.org.pl/en/o-nas/wynajem?setlang=true>
2. Select the inquiry form.
3. Complete the form and submit it.
4. Within up to 14 business days, NOSPR will inform you whether the rental of the rooms is possible and will provisionally reserve the date*.
5. The final reservation of the date will take place after the Rental Agreement is concluded.

* NOSPR reserves the right to refuse the rental of the Rooms without providing reasons.

Rent and Other Fees

Mandatory fees are specified in **Appendix 1 to the Regulations.**

Optional fees are specified in **Appendix 3 to the Regulations.**

What does the rental price include?

1. Rental of the Hall and the agreed number of dressing rooms for a specified number of hours.
2. Access to the equipment listed in the Hall's technical rider.

What does the price of basic services include?

1. Providing ticket office staff until the Event commencement;
2. Providing the following technical support during the Event: acoustics, lighting, stage*;
3. Providing cloakroom service for the Event;
4. Providing service to the audience in terms of indicating seats in the hall and providing information about the building infrastructure and the Event;
5. Ensuring verification of tickets for the Event at the entrances to the hall, provided that the Lessee submits for sale through the Lessor's sales channels a minimum of 50% of tickets for the Event;
6. Providing a person to coordinate the implementation of the Lease Agreement on the part of the Lessor during the Event;;
7. Providing cleaning service before, during and after the Event;
8. Including the Event in the calendar on the website www.nospr.org.pl- within up to 10 business days from the date NOSPR receives the complete set of materials.

*Sound reinforcement and lighting production of the Event are the responsibility of the the Lessee.

What is not included in the rental?

1. Production of the Event in terms of sound reinforcement, lighting, and installations.
2. Additional equipment for the Hall required for the concert that is not listed in the Hall's technical rider.
3. Additional equipment for dressing rooms and catering services.

Ticket Sales

The Lessee is obliged to entrust NOSPR with the sale of at least 30% of tickets at the box office and online (does not apply to festivals) and to confirm with NOSPR the list of all seats for which sales were carried out in other ticket offices in order to exclude doubles.

Entrusting NOSPR with the sale of tickets at NOSPR ticket offices and online via the www.nospr.org.pl and an external operator (e.g. Bilety24.pl) requires signing a separate agreement with NOSPR. The amount of the commission and the scope of additional services, i.e. ticket verification and coordination of the work of an external ticket office (if applicable), are specified in the Appendix No. 2 to the Regulations.

**REGULATIONS FOR THE LEASE OF ROOMS OF
NARODOWEJ ORKIESTRY SYMFONICZNEJ POLSKIEGO RADIA Z SIEDZIBĄ W KATOWICACH
AND ADDITIONAL SERVICES**

Article 1

General provisions

1. These Regulations define the terms and conditions for booking and lease of NOSPR [Narodowa Orkiestra Symfoniczna Polskiego Radia z siedzibą w Katowicach] rooms and providing additional services related to the lease of premises.
2. The Regulations apply to the Lessee, the Lessee's guests, event participants, and the Lessee's associates.
3. The NOSPR space shall be used on the terms and conditions defined in these Regulations, subject to clause 4 of this Article.
4. In events justified by social reasons or other justified circumstances, it is allowed to enter into
5. Lease Agreements and to provide Additional Services, the terms and conditions of which differ
6. from the provisions of these Regulations.

Article 2

Definitions

The terms used in these Regulations shall mean as follows:

- 1) Regulations – this document;
- 2) Lessor/NOSPR – Narodowa Orkiestra Symfoniczna Polskiego Radia w Katowicach;
- 3) Lessee - a natural person or a legal person, other organizational entity without legal personality, which makes a reservation of NOSPR rooms or has entered into Lease Agreement;
- 4) Event - concert or other event of a cultural, artistic or educational nature, as well as other events of a similar nature organized by the Lessee, conferences, trainings, workshops, presentations, symposia;
- 5) Lease Agreement - a civil-law agreement entered into by and between NOSPR and the Lessee, the subject of which is the lease of space for the needs of organizing the Event;
- 6) Rooms - space intended for lease, located in the NOSPR building located in Katowice at Pl. Wojciecha Kilar 1;
- 7) Basic Services - services provided by the Lessor related to the organization of the Event;
- 8) Additional Services - services ordered by the Lessee and provided by the Lessor, related to the organization of the Event.

Article 3

General principles of use

1. NOSPR rooms are leased for the purpose of organizing Events whose nature does not violate the good name of NOSPR and does not contradict the goals and tasks specified in the Statute of NOSPR.
2. Rooms may be leased should the normal functioning of NOSPR be ensured.
3. NOSPR reserves the right to temporarily or permanently exclude some Rooms from the possibility of leasing them for no reason.
4. Maximum number of Event participants:
 - 1) Concert Hall – 1698 (including 12 seats for people with disabilities, seats in the loge are not provided by NOSPR);

- 2) Chamber Hall – 283 persons.

Article 4.

Principles for Rooms reservations

1. To make a reservation of Rooms, the Lessee is obliged to provide the Lessor with a filled in form available at: www.nospr.org.pl. Any inquiries shall be sent to the following e-mail address: wynajmy@nospr.org.pl.
2. Within 14 business days of receiving the form, referred to in clause 1 hereof, by the Lessor, the Lessor shall preliminarily confirm consent to the lease of rooms or refusal thereof. The final reservation of the date takes place after entering into the Lease Agreement.
3. Before concluding the Agreement, the date may be reserved for a maximum of 3 weeks. If the Agreement is not concluded within 3 weeks, the reservation is cancelled. It is possible to extend the reservation in the event of contract negotiations.
4. NOSPR reserves the right to refuse to lease of the Rooms without any justification.

Article 5

General terms and conditions for leasing the Rooms

1. The Lessee may use the Rooms only in compliance with their intended purpose, for the purpose and scope specified in the Lease Agreement.
2. During the Event, the Lessor reserves the need for the constant presence of its representative.
3. The Lessee is obliged to provide the Lessor with a name list of persons responsible for organizing the Event along with contact details.
4. The Lessee and the Lessor are obliged to check the Rooms and its equipment immediately prior to the commencement and after the end of the Event. Checking the condition of the Rooms shall be documented in a form of a written report.
5. The Rooms are made available to the Lessee during the period specified in the Lease Agreement.
6. Any and all work undertaken in the Rooms, related to the organization of the Event, including, for example, assembly and disassembly of scenography, equipment and devices, may be carried out only with the documented consent of the Lessor.
7. Unloading and loading of elements provided by the Lessee for the needs of the Event is possible only at the place and time designated by the Lessor.
8. The Lessee shall not be entitled to hand over the Rooms for use in any form to third parties without the written consent of the Lessor under pain of nullity.
9. Should the Lessee use his own technical equipment (laptop, cameras, projector, etc.), he is obliged to provide the Lessor with information concerning the specifications of the said equipment and enable it to be connected and checked at least 2 calendar days prior to the Event commencement. The Lessor shall not be responsible for the malfunction of the Lessee's technical equipment used to organize the Event.
10. The Lessor shall not be responsible for the quality and content of the materials used by the Lessee during the assembly and disassembly during the Event.
11. The Lessor reserves the right to expel from the Rooms an Event participant who is intoxicated and/or under the influence of intoxicants, as well as a participant whose behaviour threatens the safety of other persons in the Rooms, who disturbs order or violates generally accepted norms of behaviour in public spaces.
12. The Lessor reserves the right to check whether persons entering the Rooms do not bring any items that threaten the safety of the Rooms and persons in the Rooms.

13. The Lessor reserves the right to verify the number of participants in the Event, in accordance with the maximum number of participants planned for the given Rooms. Furthermore, the Lessor reserves the right not to allow persons to participate in the Event whose presence will exceed the maximum number of participants.
14. The Lessor shall not be responsible for items left unattended in the Rooms. The Lessor does not enter into any storage agreement with the Lessor or with the Event participant. The Lessee is obliged to obtain the Lessor's consent to leave such items and to inform the Lessor about this fact.
15. The Lessee shall be fully liable for any loss of property, any destruction or damage to the Lessor's property, caused by the Lessee or third parties engaged by the Lessee to provide services related to the Event.
16. In the event of damage or loss to the Lessor's property, the Lessor shall draw up documentation concerning the damage together with a repair cost estimate and shall perform the repairs, whilst the Lessee shall cover the entire costs of removing the damage within 7 days of the debit note delivery.
17. The technical rider of the Rooms is an Appendix hereto.

Article 6

Basic Services

1. Under the Lease Agreement, the Lessor provides the Lessee with Basic Services:
 - 1) Providing ticket office staff until the Event commencement;
 - 2) Providing the following technical support during the Event: acoustics, lighting, stage;
 - 3) Providing cloakroom service for the Event;
 - 4) Providing service to the audience in terms of indicating seats in the hall and providing information about the building infrastructure and the Event;
 - 5) Ensuring verification of tickets for the Event at the entrances to the hall, provided that the Lessee submits for sale through the Lessor's sales channels a minimum of 50% of tickets for the Event; in the event of failure to provide at least 50% of the tickets for sale, the Lessee shall provide ticketing service on his own or shall entrust ticket verification to the Lessor for an additional fee in compliance with the principles described in the Appendix No. 2 hereto;
 - 6) Providing a person to coordinate the implementation of the Lease Agreement on the part of the Lessor during the Event;
 - 7) Providing cleaning service before, during and after the Event;
 - 8) Including the Event in the calendar on the website www.nospr.org.pl - within 10 business days from the date on which the complete set of materials is submitted to NOSPR.
2. The Lessee has the right to use the audiovisual or technical equipment in the Room, provided that the Lease Agreement so provides. The operation of audiovisual or technical equipment in the Room may only be performed by NOSPR employees/associates.

Article 7

Sales services, audience service and audience organization

1. Ticket sales for the Event may begin at the earliest after signing separate Lease and Sales Agreements.
2. The Lessee is obliged to entrust NOSPR with the sale of at least 30% of tickets at the box office and online (does not apply to festivals) and to confirm with NOSPR the list of all seats for which sales were carried out in other ticket offices in order to exclude doubles.

3. The Lessee is obliged to correctly mark the tickets in order to provide complete information about the purchase to the buyer and to ensure efficient service to the audience when entering the Concert Hall. Mandatory markings on the ticket: entrance, sector, row, seat (according to the audience plan provided by NOSPR).
4. The Lessee is authorized to sell tickets and issue invitations only to the seats indicated/marked on the audience plan provided by NOSPR. It is not allowed to designate seats or add seats outside the audience plan provided by NOSPR.
5. Entrusting NOSPR with the sale of tickets at NOSPR ticket offices and online via the www.nospr.org.pl and an external operator (e.g. Bilety24.pl) requires signing a separate agreement with NOSPR. The amount of the commission and the scope of additional services, i.e. ticket verification and coordination of the work of an external ticket office (if applicable), are specified in the Appendix No. 2 to the Regulations.
6. NOSPR reserves the right to charge additional lease for the hall lease in the cases and on the on the terms specified in Appendix no. 2 hereto.

Article 8

Czynsz oraz inne opłaty

1. The lease and additional remuneration for exceeding the agreed lease hours of the Rooms are specified in the price list constituting the Appendix no. 1 hereto.
2. The lease specified in the Lease Agreement is increased on the terms set out in Article 7, clause 6 of the Regulations, without entering into separate annexes to the Lease Agreement based on the Additional Services report.
3. The fees for Basic Services are defined in the price list constituting the Appendix no. 1 hereto.
4. The type and amount of fees for Additional Services are defined in the price list constituting the Appendix no. 3 hereto.
5. Exceeding the number of lease hours also results in an increase in the remuneration for Basic Services on the terms specified in the Lease Agreement and the Regulations.
6. Payment due dates and payment terms and conditions are specified in detail in the Lease Agreement.
7. Remuneration due to NOSPR for the provision of all Additional Services will be specified to the Lessee after the end of the lease agreement, in compliance with the price list constituting the Appendix no. 3 hereto.

Article 9

Obligations of the Lessee

1. The Lessee is obliged to:
 - 1) use the provided Rooms and technical equipment with due care and in a manner appropriate to their intended use;
 - 2) leave the Rooms in the technical and visual condition in which they were handed over;
 - 3) remove on the day of the end of the Event or on another date agreed with the Lessor of all items placed by the Lessee or Event participants in the Rooms (including scenography, technical devices, etc.);
 - 4) comply with occupational health and safety regulations, fire protection regulations and other regulations specifying the rules for the use of the Rooms;
 - 5) comply with all instructions of persons responsible for occupational health and safety.

2. The Lessee is prohibited from engaging in any behaviour that is dangerous or detrimental to the interests and good name of the Lessor. In particular, the Lessee is prohibited from:
 - 1) removing or destroying any elements of the equipment of the Rooms;
 - 2) moving elements of the equipment of the Rooms outside the space intended for them without the consent of the Lessor;
 - 3) placing any own signs in the Rooms without the consent of the Lessor;
 - 4) blocking or obstructing the use of escape routes on the Lessor's premises;
 - 5) smoking tobacco in the Rooms;
 - 6) bringing into the Rooms dangerous, flammable, explosive or poisonous materials or materials that, in compliance with their properties or applicable regulations, require special storage conditions;
 - 7) bringing into the Rooms any devices, equipment or objects which, due to their weight, size or properties, could cause damage to the Rooms or any parts thereof;
 - 8) bringing and using narcotic drugs;
 - 9) erecting and using any objects that may trigger sensors of telecommunications systems (smoke generators, dry ice generators, etc.);
 - 10) bringing animals into the Rooms, excluding guide dogs and assistance dogs;
 - 11) bringing, introducing and using bicycles, scooters, skateboards or other similar devices in the Rooms;
 - 12) conducting advertising, promotional activities, political agitations or other activities of a similar nature, not previously agreed with the Lessor;
 - 13) informing the public about the organisation of the Event at NOSPR before the date of concluding the Lease Agreement and the Sale Agreement.
3. The Lessee covers the costs of using economic copyrights, related rights, artistic performances, licenses used for works used in the implementation of the Event (including: musical works, musical works, costs of using sheet music, arrangements). Any possible claims of third parties/entities shall be in this respect borne by the Lessee.
4. If the Lessee engages NOSPR orchestra to participate in the Event, the Lessee is obliged to provide NOSPR with sheet music and arrangements to the extent enabling the proper participation of NOSPR orchestra in the Event. The deadline for delivering the sheet music is a maximum of 22 (twenty-two) days prior to the date of the Event. If the sheet music is delivered to NOSPR within 21 (twenty-one) days or less prior to the date of the Event, the Lessee is obliged to pay the Lessor liquidated damages for:
 - 1) Delay in delivery of sheet music in the period from 21 days to 14 days prior to the date of the Event - PLN 1,200.00;
 - 2) Delay in delivery of sheet music in the period from 13 days to 7 days prior to the date of the Event - PLN 1,400.00;
 - 3) Delay in delivery of sheet music in the period of 6 days or less prior the date of the Event - PLN 1,600.00.
5. In the event that NOSPR receives incomplete or missing sheet music, NOSPR may agree to print copies of the sheet music, however, NOSPR is entitled to additional remuneration for the provision of this service in the amount of PLN 1,200.00 net (in words: one thousand two hundred 00/100) increased by VAT at the applicable rate.
6. NOSPR does not print sheet music for bands/orchestras/performing artists other than its own entities.

7. In the event that the Event is cancelled or rescheduled, the Lessee shall refund ticket purchasers the full ticket price as well as any commission, service fee or other charges paid by the purchaser in connection with the purchase of the ticket.

Article 10

Final provisions

1. Current content of the Regulations is available on the website www.nospr.org.pl in the tab <https://nospr.org.pl/en/o-nas/wynajem?setlang=true>.
2. The Appendixes to the Regulations constitute its integral part.
3. The Lessor reserves the right to change the Regulations for important reasons, in particular:
 - 1) issuance by a common court of judgement or a decision by a state authority resulting in the need to change the Regulations;
 - 2) changes in legal regulations in the scope of the activity conducted by the Lessor;
 - 3) a significant change in the market situation in the scope of the activity conducted by the Lessor;
 - 4) the Lessor improving the security and functionality of the services provided;
 - 5) the Lessor improving the level of personal data protection;
 - 6) the Lessor improving the safety of event participants;
 - 7) expanding or improving the functionality of the Lessor's offer or withdrawing from making some offers available as part of the services and products offered by these Regulations;
 - 8) organizational or technical changes affecting the method of making reservations and purchasing tickets;
 - 9) the need to adapt the functioning of the Lessor or the services provided by him in the event of an epidemic or an epidemic threat or force majeure.
4. In the event that NOSPR's offer changes during the term of the agreement, the Lessee shall be bound by the obligations arising from the agreement concluded with them. The Lessee shall have the right to update their obligations to the current version of the Regulations.
5. Changes to the Regulations are effective from the date specified by the Lessor, however not earlier than within 3 days of their posting on the website: www.nospr.org.pl in the tab "<https://nospr.org.pl/en/o-nas/wynajem?setlang=true>." with the exception of changes introduced for the benefit of customers and the expansion of the Lessor's offer, which are effective from the date specified by the Lessor.
6. Considering the concern for the highest level of cultural offer and the image of the institution, the Lessor reserves the right to accept the artistic programme proposed by the Lessee.
7. The Lessor is not responsible for the organization, implementation and artistic effect of the Event.
8. To any and all matters not settled herein, provisions of the Polish Civil Code and the Lease Agreement shall apply.
